## **BIPOC-Led and Small Nonprofit Equity Fund**

Serve Washington is pleased to announce a Request for Grant Applications for the *BIPOC-Led and Small Nonprofit Equity Fund*. The grant period will begin December 1, 2022, and end June 30, 2024. Proposals will be accepted on a rolling basis as funds are available. Requests must be submitted via the <u>BIPOC-Led</u> and <u>Small Nonprofit Equity Fund Request</u> form.

**Purpose:** Supported by the Schultz Family Foundation, Serve Washington has created an equity-focused fund to increase the engagement and participation of BIPOC-led and small community-based nonprofit organizations in AmeriCorps. The primary goal is to diversify nonprofit organizations that are hosting, supervising, and growing AmeriCorps members. We anticipate awarding up to \$580,000 in total funding to address financial and capacity barriers through providing host site fee subsidies, training and technical assistance, and creating a BIPOC Leadership Fellowship. Specifically, Serve Washington will award BIPOC-led organizations and nonprofits new to AmeriCorps serving in marginalized communities.

**Eligibility:** Organizations applying for this grant must be community-based and have a partnership with an existing AmeriCorps program operating in Washington State and fall under the following criteria:

- BIPOC-led (an organization whose CEO or Executive Director is BIPOC OR staff is 50% or greater BIPOC OR Board of Directors is 50% or greater BIPOC, AND whose mission statement and charitable programs aim to predominantly serve BIPOC communities or populations)); or,
- New to hosting an AmeriCorps member **AND** have an operating budget of less than \$2 million. For the purpose of this fund an organization is considered new to AmeriCorps for one three-year AmeriCorps cycle.

**Available Funds:** \$580,000 in funding is currently available to organizations in the state of Washington. The amount of funding you are eligible for is dependent on the following factors:

- ➢ Is your organization BIPOC led and serving?
  - ✓ Yes
- ➢ Is your budget less than \$2 million?
  - ✓ Yes, our budget is less than 2 million annually and we are a BIPOC led and serving organizations.
    - Great! You may be eligible for up to 100% of the host site fee being supported, depending on your year of support. See below chart.
- ➢ Is your budget greater than \$2 million?
  - ✓ Yes, our budget is more than \$2 million annually and we are a BIPOC led and serving organization.
    - Great! You may be eligible for up to 75% of the host site fee being supported, depending on your year of support. See below chart.

- > Are you new to AmeriCorps but not a BIPOC led and serving organization?
  - ✓ We are not new to AmeriCorps.
    - Sorry, you do not qualify for this support.
  - $\checkmark$  Yes, we have never hosted an AmeriCorps member, or have only hosted for one year.
    - Great! You qualify for up to \$5,000 per full time member to support hosting an AmeriCorps member.

Serve Washington will have a budget for consulting, training, and technical assistance through prescribed vendors for recipients of this fund.

**BIPOC** leaders are invited to participate in a peer-to-peer think tank for organizational development, leadership, and sustainability. Each identified leader will be notified separately with additional details.
